

## Convention and Exhibition Industry Subsidy Scheme (Second Part)

### Application Guide (Private Organisers)

(updated on 17 February 2021, 20 July 2021, 7 October 2021 and 10 June 2022)

#### Convention and Exhibition Industry Subsidy Scheme Latest requirements

To align with the Government's latest anti-epidemic measures, all organisers applying for the Convention and Exhibition Industry Subsidy Scheme from 18 February 2021 have to ensure that the events concerned comply with the following health and anti-epidemic measures:

(i) For events held on or before 21 July 2021, prevailing restrictions imposed on place of public entertainment by the directions issued by the Secretary for Food and Health under the Prevention and Control of Disease (Requirement and Directions) (Business and Premises) Regulation (Cap. 599F), irrespective of whether a Temporary Places of Public Entertainment Licence is required for the event concerned; for events held on or after 22 July 2021, prevailing restrictions imposed on place of public entertainment or event premises (as applicable) by the directions issued by the Secretary for Food and Health under the Prevention and Control of Disease (Requirement and Directions) (Business and Premises) Regulation (Cap. 599F).

(ii) Extra health and anti-epidemic measures targeting convention and exhibition activities

The application forms attached herewith have been updated (updates in blue and red). Organisers have to confirm in the application forms (Forms A2 or B) that the events are in compliance with the relevant requirements, which would be confirmed by the venue operators. Government staff will conduct random spot checks to ensure that the events concerned comply with the relevant requirements. In case of non-compliance, the organisers will not be eligible for the subsidy.

## Introduction

The Second Part of the Convention and Exhibition Industry Subsidy Scheme (the Scheme) is set up under the Anti-epidemic Fund to provide subsidies to eligible organisers of exhibitions and international conventions held between 3 October 2020 and 31 December 2022 (both dates inclusive) at the Hong Kong Convention and Exhibition Centre (HKCEC) and AsiaWorld-Expo (AWE) equivalent to 100% of the venue rental<sup>1</sup>.

## Eligibility

2. For the purpose of the Scheme, exhibitions and international conventions that are eligible for the subsidy are defined as follows:

- (a) **Exhibitions:** demonstration or display of products, materials and/or services by multiple sellers to multiple buyers with an aim to trade such products, materials and/or services whether inside or outside of the venue, and such demonstration or display occupies no less than 1,200 square metres of gross floor area (GFA).
- (b) **International conventions:** formal meeting of delegates for knowledge and information sharing on a particular subject under an organised agenda, with (i) over 400 participants; **AND** (ii) at least 50% of the participants are non-local (i.e. from outside Hong Kong).

3. Exhibitions and international conventions must have started within the period between 3 October 2020 and 31 December 2022 (both dates inclusive) to be eligible. Events starting within the aforementioned period but ending beyond 31 December 2022 are still eligible. For the avoidance of doubt, the ‘start’ date of an event is the date when it actually takes place at the venue, irrespective of the licensing period, move-in/out period or when an organiser submitted an application under the Scheme.

4. An event is eligible for subsidy under the Scheme if more than 50% of the GFA of the event is used as an **Exhibition** or an **International Convention**. If an event lasts for more than one day, the usage of the GFA of the event shall be calculated as follows: the summation of the GFA used for a particular purpose on each day of the event divided by the summation of the total GFA of the event on each day of the event.

<sup>1</sup> The subsidy level of 100% of the venue rental applies to all exhibitions and international conventions held within the validity period of the Scheme.

## **Subsidy disbursement**

### (i) For exhibitions that have been held in Hong Kong for the past five years (or ten years for biennial exhibitions)

5. For private exhibition organisers which have good track record, i.e. their exhibitions have been held in HKCEC or AWE for the past five years (i.e. 2015 to 2019 or 2016 to 2020 for annual exhibitions; 2010 to 2019 or 2011 to 2020 for biennial exhibitions) as confirmed by the venue operators, they may apply for receiving advance payment of 50% of the venue rental. In other words, they will pay 50% of the venue rental to the venue operators according to the licensing agreement, and the Government will pay, on behalf of the exhibition organisers, the remaining 50% to the venue operators one month before the exhibitions. After the amount of the advance payment is determined and paid as at one month before an event, the Government will not recall any excess advance payment should there be subsequent decrease in the venue rental, while any subsequent increase in venue rental should be settled by the organisers and the Government will disburse the subsidy after the event.

6. Applicants who wish to receive advance payment will need to submit an application form (**Form A1**) and pay 50% of the venue rental to the venue operators at least **two months before the exhibitions**. Within two months after completion of the exhibitions, applicants should submit **Form A2** to the venue operators to confirm final venue rental and event turnout. The Government will endeavour to disburse the subsidy equivalent to the remainder of the venue rental over the advance payment to the organisers through the venue operators within 12 working days after receipt of duly completed application forms.

7. If an exhibition is eventually cancelled or is postponed to a date beyond the validity period of the Scheme, the organiser concerned must pay back the Government, via the venue operator, the entire advance payment within one month after the organiser has made the decision to cancel or postpone the exhibition.

### (ii) For other exhibitions and international conventions

8. For other organisers which are not eligible for receiving the advance payment of subsidy or do not wish to receive advance payment of subsidy, they are required to submit applications (**Form B**) to the venue operators **within two months after**

**completion of the events.** After vetting, the Government will disburse the subsidy equivalent to the paid venue rental to the successful applicants via the venue operators. Subject to the organiser's submission of a timely and complete application, disbursement is expected to be made through the venue operators within 12 working days after receipt of the duly completed application form.

### **Application materials**

9. Applicants are required to complete the application form attached to these guidelines and submit to the venue operators. For organisers of international conventions, the application form has to be accompanied by an auditor's report prepared by a Certified Public Accountant of the Hong Kong Institute of Certified Public Accountants (or equivalent) which confirms the fulfilment of the requirement regarding the number of participants, including the proportion of non-local participants, as stipulated in paragraph 2(b) above.

10. Applicants must complete all applicable entries of the application form to be eligible. Applications with incomplete information (even after request) will not be processed. Any applicants knowingly or wilfully makes a false statement, misrepresenting or concealing any information in order to obtain subsidy under the Scheme by deception commits a criminal offence and is liable on conviction to imprisonment. Any misapplied subsidy or advance payment must be returned to the Government.

**Extra health and anti-epidemic measures targeting  
convention and exhibition activities**

- (a) Organisers must comply with the health and anti-epidemic measures stipulated in the guidelines for convention and exhibition (C&E) activities prepared by the venue operators;
- (b) Venue operators and organisers shall assign staff to monitor and control visitor traffic, in order to avoid excessive visitors gathering at particular exhibition booths;  
and
- (c) If a person confirmed to be contracted with COVID-19 visited the C&E event, the venue operators and organisers shall follow the advice of the Centre for Health Protection to adopt health precautionary measures.
